Classifications

Group 1 chemicals are **collected FREE*** under the program, these chemicals are currently registered Ag and Vet chemicals manufactured by companies supporting the Industry Waste Reduction Stewardship initiative.

Group 2 chemicals are those chemicals that are no longer registered, unknown, unlabelled, out of date, or mixed AgVet chemicals. A fee applies for disposal unless a state government subsidy is in place.

Collecting unwanted Ag and Vet chemicals

Users of ag vet chemicals utilise store personnel and agronomists for information when purchasing chemical. Chemical users rely on this information for the correct use, handling and storage of that chemical. Please add disposal to the information your staff provide.

Inform your clients that there is an easy disposal service available to them. Our service can be utilised for change of use, out of date, surplus, unwanted, old, unknown or obsolete chemicals.

ChemClear invites local Shire Councils to provide a safe collection site for the retrieval of these chemicals once registrations in the shire area are received. If this site is unavailable or unsuitable to collect from, ChemClear will approach the local reseller stores to consider providing a Host Site.

Reseller's Can Utilise the Program

Resellers can utilise the ChemClear service for any unwanted stock they are holding under a user pays system.

Reseller Policy

A Reseller Policy was instituted on 1st January 2007. This Policy allows for **40 lt/kg per year, per store** of Group 1 classified chemicals (currently registered) to be registered with the program for collection and disposal. Bulk disposal of **Group 1** classified chemicals can be undertaken with no weight limitation. **A per lt/kg fee for disposal applies.**



The **Group 2** service is available to Resellers with no limit on registration. These chemicals are unlabelled, mixed, unknown or deregistered. **Group 2 chemicals attract a per lt/kg fee for disposal.**
