

Become a ChemClear Host Site



Supporting farmers and protecting the land, with the collection of unwanted AgVet chemicals

ChemClear® is an industry stewardship program funded to collect currently registered agricultural and veterinary (AgVet) chemicals at the end of their life cycle, or when they become surplus or unwanted.

Appropriate collection and disposal of the chemicals minimises their impact on the environment than if they're otherwise neglected. The service ensures possible environmental contaminants are retrieved, in turn reducing waste and the possibility of residual contamination.

Invitation to participate

We invite local governments to participate in the ChemClear program by hosting a collection site.

The objective is to work in partnership with councils to provide a suitable AgVet collection service for their community.

Waste holders who have registered for our service are given an appointed time to drop off their registered chemicals directly to our retrieval team at the council host site.

To get involved

Councils are not required to sort, store, handle or hold any chemical waste on behalf of our program.

To get involved, councils will need to complete a Council Site Nomination Form to nominate an appropriate site for a ChemClear collection.

ChemClear carries out "milk run" style collections and will only require the host site for approximately 1-3 hours on the scheduled day.

Communications

ChemClear provides councils with:

- A ChemClear metal sign to place at their nominated site,
- Campaign ads and media releases for council to use in the lead up to a collection,
- Promotional materials,
- Reports on waste collected from the council zone at the end of the collection.

Close contact

ChemClear works closely with councils and waste holders who have registered for the program, to establish suitable sites for the chemical to be collected from.

ChemClear scope

ChemClear collects from persons, businesses and organisations undertaking:

- Agricultural and livestock production
- Industrial and recreational pest and weed control
- Forestry
- Similar activities conducted by local, state and federal government agencies.

The program targets the disposal responsibilities of AgVet chemical users, while diverting potential hazardous chemicals from being dumped inappropriately, or ending up in landfill or creeks.
